The regular monthly membership meeting of Wednesday, May 20, 2009, has been <u>rescheduled</u> to Monday, May 11, 2009, nine (9) days earlier. Upon commencement of this meeting, <u>nominations</u> for the offices of President, Vice President, Business Manager, Financial Secretary-Treasurer, ten (10) Business Agents, Recording Secretary, four (4) Executive Board Members, three (3) Finance Committee Members, six (6) Examining Board Members and Inside Sentry will be accepted and seconded from the floor.

As per Section 121 of the United Association Constitution, "No member shall be eligible to be nominated for office in any Local Union unless he shall be a journeyman member and shall have been a member of the United Association and the Local Union in good standing for at least a period of two (2) years immediately prior to the election. Any journeyman member who owes or has paid a reinstatement fee within a period of two (2) years immediately prior to the date of the election shall not be eligible to be nominated for office in any Local Union."

The secret ballot machine election for Plumbers Local No. 1 Officers will be held on Saturday, June 6, 2009. Polls will open at 8:00 A.M. and close at 4:00 P.M. Tabulation to follow.

In the event of a tie vote, a runoff election will be held on Saturday, June 13, 2009 from 8:00 A.M. to 4:00 P.M.

All meetings and elections will be held at Plumbers Local No. 1 Trade Education Facility, 37-11 47th Avenue, Long Island City, NY.

As per Section 124(a) of the United Association Constitution, "No member shall vote at any election of any description unless he has been a member in good standing in the Local Union where the vote is being taken for a period of one (1) year immediately prior to the date of election. Any member who owes or has paid a reinstatement fee within a period of one (1) year immediately prior to the date of election shall not be eligible to vote in any Local Union election."

Members must bring their signed membership card and one additional form of identification in order to vote.
