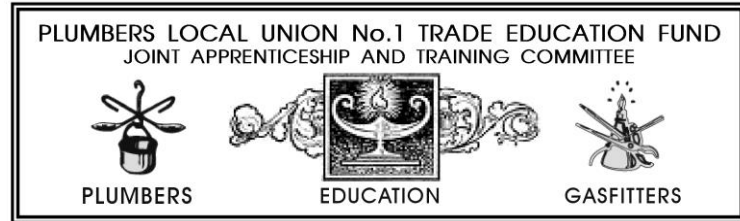

NEW *SAFETY* LAW THAT REQUIRES NEW TRAINING

An information message from your Plumbers and Gas-Fitters Local Union No. 1 Joint Apprenticeship & Training Committee

Recently, New York City passed **Local Law 196**, increasing **safety training** requirements for the city's construction workers. The Department of Buildings will require workers to have **40 hours** of safety training. These requirements apply to workers at sites for which the DOB requires construction superintendents, site-safety coordinators, or site-safety managers. **The changes are taking effect in stages over several months.**

{NYC} SITE SAFETY TRAINING LAW (SST)

{NYC Local Law 196 of 2017}

UPDATED DEADLINES: **YOU WILL NOT BE ALLOWED ON THE JOB WITHOUT A CARD!**

March 1, 2018 **PHASE 1** – All construction workers must have **OSHA 10**

June 1, 2019 **PHASE 2** – All construction workers must have **OSHA 30 (Approved type)**

September 1, 2020 **PHASE 3** – All construction workers must have a **40 hour SST* Card**

* SST stands for Site Safety Training

On – Line OSHA 30-HOUR CONSTRUCTION with VOICE-AUTHENTICATION

The Plumbers Local 1 Trade Education Fund has arranged a special discounted rate for our participants. To get the 35% discounted rate you need to go to the members only section of the Local 1 WEBSITE.

Upon successful completion, you can print a temporary completion certificate.

ClickSafety records your score and submits a report of successful completion to OSHA and the US Department of Labor. Your DOL/OSHA Completion Card is sent to ClickSafety for signature and then mailed directly to you. Cards typically arrive 6 to 8 weeks after the successful course completion date.

Some important things to know about how OSHA 30 will be used to get an **SST CARD** later on:

40 Hour Site Safety Training (SST) will be verified using a NYC Department of Buildings “card” system. **SST CARDS** will be issued to those who complete OSHA 30 Construction, plus 10 ADDITIONAL HOURS.

Not all OSHA 30 cards will be acceptable for an SST card!

OSHA 30 Cards received through “in person” training WILL be acceptable.

OSHA 30 Cards received through “on-line” training which IS “Actively Proctored” WILL be acceptable.

OSHA 30 Cards received through “on-line” training which is NOT “Actively Proctored” will NOT be acceptable.

OSHA 30 Cards more than 5 years old at the time you apply for an SST card will NOT be acceptable.

Voice-Authentication courses address Local Law 196 (SST) online course proctoring requirements. The **ClickSafety OSHA 30 Construction online** course is a proven way to receive a valid OSHA 30 Card for SST.

OSHA 30 + 10 MORE gets you a 40 hour SST Card!

Flip to the back page to schedule a class for the **10 more** you need.

SST-10 (A Plumbers & Gas-Fitters Local 1 Training Center Course)

The SST-10 course will be offered in-house in our Training Center to provide the 10 hour supplement needed to combine with an OSHA 30 card in order to get an SST card from the NYC Department of Buildings.

This is a 10 hour combined course. It is comprised of an 8 hour "Fall Prevention" class and a 2 hour "Drug and Alcohol Awareness" class. The SST-10 course runs for 3 evenings. You must be present all 3 evenings to receive credit. Completion certificates will be issued. SAVE YOUR COMPLETION CERTIFICATES!

In order to later receive a full SST card from the NYC Department of Buildings, you will need to submit:

- A) A valid OSHA 30 card (meeting all requirements of the SST program).
- B) An "8 hour Fall Prevention" completion certificate (Issued by Trade-Ed).
- C) A "2 hour Drug and Alcohol Awareness" completion certificate (Issued by Trade-Ed).
